NBS/PRISM TO ADD BUTTON TO ADMINISTRATIVELY CLOSEOUT DIGITAL NBS/PRISM RECORD

The proper administration of contract awards, including closeout, and the subsequent closeout of the *digital* NBS/Prism record is very important. Consequently, we want to ensure that NIH is continually improving in this important area.

Therefore, on or about June 3, 2015, when the NBS comes back up from the R12 upgrade, all PRISM record owners, buyers and contracting officers (approvers) will be provided with access to a “Closeout” button in NBS/Prism. Access to the closeout button will allow award file owners, buyers and contracting officers, to administratively close the *digital* NBS/Prism record after proper administrative closeout procedures (FAR 4.804) of the official contract file have been completed, including documenting the official contract file with a properly executed receiving report (FAR 32.905 (c)) and evidence of final payment.

Additional information will be forthcoming in future OALM Communications, OALM Newsletters, and other venues regarding the process for closing out awards issued under Simplified Acquisition Procedures (SAP) and the Simplified Acquisition Threshold (SAT). Also, training will be made available for Simplified Acquisition staff in the Offices of Acquisition and staff in the Delegated Offices of Acquisition on how to properly closeout an award under the SAP/SAT including use of the new closeout button. NIH AWARDS NEW GOVERNMENT-WIDE IT CONTRACT

The National Institutes of Health Information Technology Acquisition and Assessment Center (NITAAC) announced the award of its newest government-wide acquisition contract (GWAC) for information technology: Chief Information Officers – Commodities and Solutions (CIO-CS). This new contract covers 10 years with potential funds totaling \$20 billion to provide the entire federal government with IT solutions.

This GWAC offers IT commodity-enabling and shared solutions both on-site and in the cloud. This includes services such as deployment and installation, maintenance and training, engineering studies, enterprise licenses and extended warranties, everything-as-a-service, mobility, collaboration, web and video-conferencing, cyber security, big data, virtualization and health and biomedical IT.

Of the 65 companies awarded a CIO-CS contract, 44 are small businesses across multiple socioeconomic categories. There are eight HUBZones, 14 women-owned, six 8(a), seven economically disadvantaged women-owned small businesses and six service-disabled veteran-owned small businesses. All awardees went through a competitive source selection process to ensure the most technically capable and competitively priced solutions will be available over the next 10 years.

CIO-CS follows the awards of the CIO-SP3 and CIO-SP3 Small Business. "Our vision was to create a strong suite of contracts which meet the IT needs of not only NIH but the entire federal landscape," said Diane J. Frasier, director, Office of Acquisition and Logistics Management and head of the Contracting Activity at NIH.

"With its emphasis on cloud and managed services, we expect CIO-CS to appeal to a

broad base of customers throughout the government tasked with implementing IT solutions," added Brian Goodger, associate director of the NIH Office of Acquisitions and Logistics Management.

"We will continue to build strong relationships with our customers through superior customer service and quality contracting. This contract introduces a new, highly select community now poised to serve the federal government's emerging, next generation information technology needs within a culture that embraces uncompromising quality and bold innovation," said Robert Coen, NITAAC program director. The 65 winners selected for this highly sought-after award can be found on the NITAAC website.

NBS Image File Uploading Status




Figure 1 - NBS Image File Uploading Status
